The Gift-aid Declaration:

For every £1 you give to Kindred, we get an extra 25 pence from the Inland Revenue.

So just tick the box above, it's that simple. To qualify for Gift Aid you must pay an amount of Income Tax or Capital Gains Tax each tax year (6 April one year to 5 April the next), at least equal to the amount of tax that all the charities you donate to,

will reclaim on your gifts for that tax year. Other taxes such as VAT and Council Tax do not qualify. Kindred will reclaim 25p of tax on every £1 that you have given. We can only claim Gift Aid if you give us your full home address, not an organisation's address. (Please see further notes overleaf)

*** Notes on your declaration:**

1. You can cancel this Declaration at any time by notifying Kindred
 2. If your circumstances change and you no longer pay enough income or capital gains tax to cover the amount claimed by Kindred, please contact Kindred
 3. If you pay tax at the higher rate, you can claim further tax relief via your Self Assessment tax return (currently 25p for each pound you give)**
 4. Please notify Kindred if you change your name or address
- * Gift Aid is linked to basic rate tax. Basic rate tax is currently 20%, which allows charities to reclaim 25 pence on the pound.
- ** Higher rate taxpayers can claim back the difference between basic rate and higher rate tax.
